

# SPRINT TWIN TO WIN SWEEPSTAKES

## OFFICIAL RULES

### NO PURCHASE REQUIRED TO ENTER OR WIN

- 1. ELIGIBILITY:** The Sprint Twin To Win Sweepstakes (the “Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen years of age or older. Employees of Sponsor, Prize Logic, LLC (“Administrator”), or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and void where prohibited.
- 2. SPONSOR:** The Sweepstakes is sponsored by Sprint Communications Company L.P. (the “Sponsor”).
- 3. AGREEMENT TO OFFICIAL RULES:** Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 4. SWEEPSTAKES PERIOD:** The Sweepstakes begins on May 22, 2017 at 12:00 AM ET and ends on May 29, 2017 at 11:59:59 PM ET (the “Sweepstakes Period”) and consists of eight (8) entry periods (each an “Entry Period”) as outlined in the chart below:

Entries that are submitted before or after the Sweepstakes Period will be disqualified. Non-winning Entry Period entries will not carry-over into subsequent Entry Period drawings. The Administrator’s computer is the Sweepstakes official clock.

- 5. HOW TO ENTER:** There are three (3) ways to enter the Sweepstakes:
  - A. Facebook:** An entrant must visit <https://www.facebook.com/sprint/> (the “Website”) and look for the Facebook posts showing how to enter this Sweepstakes (each a “Post”).

If you do not have a Facebook account you may sign-up for free by visiting [www.facebook.com](http://www.facebook.com) and follow the instructions to register for an account. Registration for and use of Facebook and other Facebook applications are subject to Facebook's terms and conditions (<https://www.facebook.com/legal/terms>) and Sponsor has no responsibility with respect to such registration or use. Once a member of Facebook, entrant must visit the Website and upload a photo in the comment section of the Post showing entrant twinning with his/her pet and include the hashtags #Twin2Win and #Sweepstakes. Entrant will receive one (1) entry into the respective Entry Period during which he/she posted the comment. Anyone found to use multiple Facebook accounts to enter will be ineligible. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Facebook.

**B. Twitter:** An entrant must sign into his/her Twitter account and follow @Sprint. Entrant must then post a photo of entrant twinning with his/her pet including the hashtags #Twin2Win and #Sweepstakes. Entrant will receive one (1) entry into the respective Entry Period during which he/she posted the photo. Each Tweet must be public (not protected), include the hashtag above and conform to Twitter's (140) character limitation. By entering the Sweepstakes and using the hashtags #Twin2Win and #Sweepstakes, entrant hereby agrees to be bound by these Official Rules. An entrant must have a non-private Twitter account to enter the Sweepstakes via this method and must be a follower of @Sprint at least 30 days after the Sweepstakes Period for winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting [www.twitter.com](http://www.twitter.com). Please note that an entrant must agree to comply with the Twitter Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) in order to participate in the Sweepstakes. **C. Instagram:** An entrant must sign into his/her Instagram account and follow @Sprint. Entrant must then post a photo of entrant twinning with his/her pet including the hashtags #Twin2Win and #Sweepstakes. Entrant will receive one (1) entry into the respective Entry Period during which he/she posted the photo. To participate via Instagram, an entrant must have a non-private Instagram account to enter the Sweepstakes via Instagram and maintain such non-private account for at least thirty (30) days after the Sweepstakes Period ends to be eligible to win/claim a prize for notification purposes. An entrant may create an Instagram account at no cost at <https://instagram.com>. Creation of an Instagram account requires entrant to agree to Instagram's Terms of Use and Privacy Policy, available at <https://help.instagram.com/478745558852511> and <https://help.instagram.com/155833707900388>, respectively. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram.

**Entry Requirements:** All Entries must comply with the following restrictions:

- Entry must contain the hashtags #Twin2Win and #Sweepstakes;
- Entry must be an original work;

- Entry must be in English (except for commonly understood foreign words);
- Entry must comply with Twitter terms of use located at <https://twitter.com/tos/>, Instagram terms of use located at: <http://instagram.com/about/legal/terms/>; and/or Facebook terms of use located at [https://www.facebook.com/legal/terms](https://www.facebook.com/legal/terms;);
- Entry cannot have been published previously by any party other than the entrant;
- Entry must be suitable for publication (i.e., may not be obscene or indecent);
- Entry cannot contain trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor's;
- Entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);
- Entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person;
- Entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Entry cannot promote illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;
- Entry cannot describe or depict any illegal activity or violation of any state or federal law;
- Entries must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);
- Entries must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
  - gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
  - the use of prostitution, pornography, nudity, profanity or other adult content, or violence;
  - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Entry must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way.

If any entry fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, at the Sponsor's sole discretion, Sponsor reserves the right to disqualify the entrant.

By submitting an entry and using the hashtags #Twin2Win and #Sweepstakes, each entrant hereby agrees to the terms and conditions set forth in these Official Rules and each entrant agrees that his/her entry conforms to the entry guidelines and restrictions set forth above. Submitting an entry constitutes entrant's grant to Sponsor, its parents and affiliates, and the employees, officers, directors, licensees, designees, agents, successors and assigns (collectively, "Grantees"), of a royalty-free, irrevocable, perpetual, nonexclusive license to use, reproduce, modify, post, distribute, publish or create derivative works from and display the entry in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for

promotional, advertising, public relations, trade show and/or marketing purposes, without further compensation, notification or permissions of any kind except where prohibited by law. If requested, entrant will sign any documentation that may be required for Sponsor or its designees to make use of the nonexclusive rights entrant is granting to use the entry. This license expressly includes a right (but not the obligation) for Sponsor to modify entries to remove any third party intellectual property. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the entry for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. Each entrant hereby acknowledges that such entrant does not reserve any rights in or to the entry. The displaying of an entry on any website/social media platform does not constitute verification of eligibility or compliance with these Official Rules and all entries and entrants remain subject to verification of eligibility and compliance with these Official Rules as determined by Sponsor at its sole discretion. Entries that do not follow the above formats and Entry Requirements may be discarded or ignored and not eligible for entry. Entries received after the Sweepstakes Period and/or entries that contain obscene, offensive, or any language communicating messages inconsistent with the positive images to which Sponsor wishes to associate will be void. Anyone found to use multiple Facebook, Twitter, or Instagram accounts to enter will be ineligible.

**Limit:** One (1) entry via Facebook, one (1) entry via Twitter, and one (1) entry via Instagram per person per Entry Period during the Sweepstakes Period. Any attempt by an entrant to enter more than the number of times authorized herein, including multiple entries by the same entrant using different social network accounts, may, at the Sponsor's sole discretion, invalidate ALL entries submitted by that entrant for the entire Sweepstakes Period. Entries will be deemed made by the authorized account holder of the social media account that is used to submit the entry. The "authorized account holder" is the person who is assigned to the social media account by the respective online service provider (i.e., Facebook Twitter, or Instagram).

By participating in the Sweepstakes, entrant understands that he or she is providing his or her information to Sponsor and not Facebook, Inc. ("Facebook"), Twitter, Inc. ("Twitter"), or Instagram, LLC. ("Instagram"). Further, Entrant specifically agrees to release Facebook, Twitter and Instagram from any and all liability associated with this Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, Instagram, or any of their affiliates.

6. **DRAWING:** On or about each of the dates indicated in the chart above in Section 4, two (2) potential winners will be selected in a random drawing of all eligible entries received for

that respective Entry Period for a total of sixteen (16) potential winners. The odds of being selected depend on the number of entries received for each respective Entry Period. The Sponsor will attempt to notify the potential winners within five (5) days of the drawing.

- 7. REQUIREMENTS OF POTENTIAL WINNERS:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. The potential winners will be notified on either Facebook by Direct Message, on Twitter by a Direct Message from @Sprint, or on Instagram by a Direct Message from @Sprint (depending on his/her method of entry) with instructions on how to claim a prize. The potential winners must respond to the Facebook, Twitter, or Instagram Direct Message winner notification within twenty-four (24) hours or the potential winner may, in Sponsor's sole discretion, be disqualified. Each potential winner will be required to complete and return an affidavit of eligibility and liability/publicity release (the "Affidavit/Release") within five (5) days of being notified. If a potential winner cannot be contacted or fails to sign and return the Affidavit/Release within the required time period, he/she will be disqualified and an alternate entrant may be selected in his/her place in a random drawing of all entries received during the respective Entry Period. If a potential winner is a minor, his/her parent or legal guardian must sign the Affidavit/Release on the potential winner's behalf. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Prizes are not transferable and include only the items specifically listed as part of the prize. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the prize won. Approximate retail values are as of the time these Official Rules were printed and the value of the Prize may fluctuate. The winners are not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. Sponsor will issue an IRS Form 1099 for each winner. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each prize will only be awarded to a verified winner. Prizes will only be delivered to addresses within the fifty (50) United States and the District of Columbia.
- 8. PRIZES:** Each winner will receive a Samsung Galaxy S8. There will be a total of sixteen (16) prizes awarded (two [2] per Entry Period) during the Sweepstakes Period. The approximate retail value ("ARV") of each prize is \$661.00. The total ARV of all prizes is \$11,200.00.

Wireless service is NOT INCLUDED with any of the prizes. Any and all fees and costs associated with the device activation and/or use of the prize are the sole responsibility of the winner. In no event will more than sixteen (16) prizes be awarded during the Sweepstakes Period. If, for any reason, more prize notifications are sent than the eight (16) offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. Any prize details not specified above will be determined by the Sponsor in its sole discretion. Prizes are not transferable or refundable and must be accepted as awarded. No cash or other substitution may be made, except by the Sponsor, who reserves the right to substitute a prize (or component thereof) with another prize (or component thereof) of equal or greater value if the prize is not available for any reason as determined by the Sponsor in its sole discretion. Each winner is responsible for any and all other costs and

expenses not listed above. Prizes may be reported as income to a winner and the winner will be responsible for all taxes associated with the receipt of a prize. Limit: One (1) prize per person.

9. **PRIVACY AND PUBLICITY:** All information submitted by entrants in the Sweepstakes will be treated according to Sprint's Privacy Policy, available at [www.sprint.com/privacy](http://www.sprint.com/privacy). Except where prohibited, participation in the Sweepstakes constitutes an entrant's consent to the Sponsor's use of his/her name, likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any media without further payment or consideration.
10. **GENERAL CONDITIONS:** In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules or (b) award the prizes at random from among the eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the participant. The "authorized account holder" is the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
11. **RELEASE AND LIMITATIONS OF LIABILITY:** By participating in the Sweepstakes, entrants agree to release and hold harmless the Sponsor, Administrator, Facebook, Inc., Twitter, Inc. and Instagram LLC, and their parent, officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) any technical errors that may prevent an entrant from submitting an entry; (b) unauthorized human intervention in the Sweepstakes; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes or the processing of entries; or (f) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

DISPUTES:** Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Kansas. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Kansas, without giving effect to any choice of law or conflict of law rules (whether of the State of Kansas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Kansas. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN KANSAS.
